I further agree to release the State of Utah, **Rocky Mountain Middle School**, their agencies, departments, officers, employees, agents and all sponsors, officials and staff or volunteers from any and all liability, claims, demands, breach of warranty, negligence, actions, and causes of actions whatsoever for any loss, claim, damage, injury, illness, attorney's fees or harm of any kind or nature to me arising out of student's participation in this **Rocky Mountain Middle School** course/program. This release extends to any claim made by parents or guardians or their assigns arising from or in any way connected with the aforementioned activities.

Students are not allowed to bring arrows, but can bring the approved NASP bow to the school. As part of the Safe School Policy we cannot have students having arrows outside of the range.
